Animal Shippers Meet in Calgary

Calgary, AB., March 18, 2005: Traceability & Security — two issues that affect everyone involved in transport of animals - will be the theme for the international Animal Transportation Association (ATA) Conference to be held in Calgary May 1 – 4, 2005 at the invitation of the Calgary Airport Authority. In cooperation with Alberta Farm Animal Care (AFAC), a Livestock Truckers Workshop will be held on final day of the Conference.

Traceability is a key issue in the live animal industry as countries develop means of permanently identifying all species of animals, their source of origin and tracking them during transport. In Europe, TRACES will be a main component of the EU's traceability plan. In addition, the traceability requirement and increased security during all steps of a shipment place new responsibilities on all parties involved in the animal transport chain.

Attendees at ATA's 31st Annual Conference will learn about the latest procedures in security and recent changes required of the airlines, the port authorities, the forwarders and anti-terrorism training programs available for companies. They will learn about a new satellite-tracking program for animals and about varying countries' animal identification programs.

Attendees will learn how international organizations are now jointly cooperating on creating a standard Code of Practice to serve as a guideline for transport of all animals. They will learn about the changes countries have made to control the spread of disease following an outbreak such as BSE or Avian Influenza as well as the economic and animal welfare impact of such outbreaks. Presentations will focus on dealing with animal incidents through advance planning, cross training and statistical reporting.

Presentations on unique transports will give an inside look at the challenges of grizzly rescues, whooping crane transport, transporting cold water and tropical fish, performance horses, non-human primates and dealing with sheep that are stranded at sea for two months.

A special invitation is being extended to truckers, feedlots and auctions by AFAC who is organizing and sponsoring the **Wednesday, May 4th, Livestock Trucking Workshop focusing on The Commercial Transport of Livestock in North America**. Presentations will address:

- ✓ factors that contribute to **stress and recognizing signs of stress during transport**;
- ✓ liability, responsibility and insurance for animal handlers, their equipment and the animals in their care;
- ✓ defining of overloaded versus overcrowded when loading animals;
- ✓ the definition of an unfit animal;

- ✓ use of on-board disinfection systems for trucks;
- ✓ the price of bruised animals upon arrival at market;
- ✓ special needs cargo such as the sensitivity of swine and poultry;
- ✓ the latest regulations on transport of slaughter horses;
- ✓ commercial livestock trucking accidents;
- ✓ training of livestock transporters and;
- ✓ a look at the similarities and differences between the North American, European and Australian trucking industry.
